

VIDEOBADGE VB-300 TECHNICAL SPECIFICATIONS

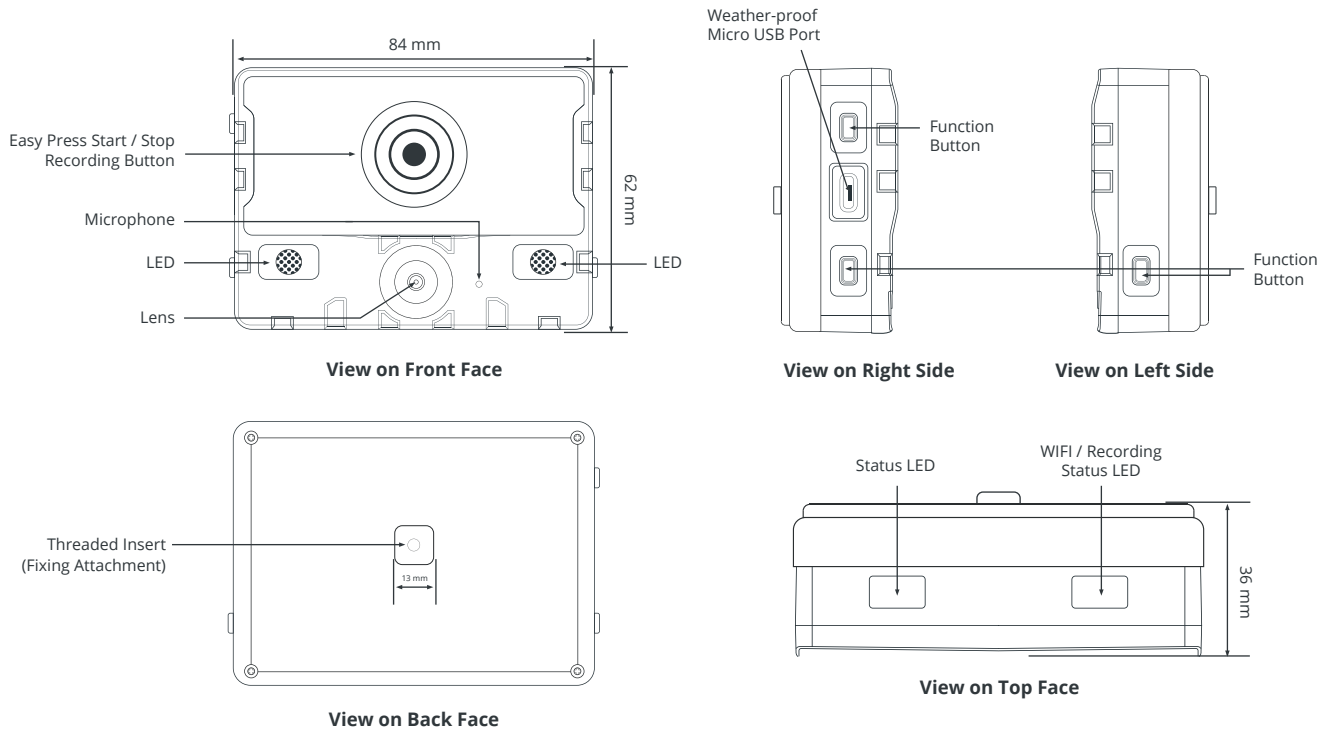
The VB-300 series of Body Worn Cameras represent the first generation of WiFi enabled VideoBadges by Edesix.

With a 130 degree horizontal field of view, day & night recording capability, RFID touch-assign enabled and integrated pre-record function, VB-300 VideoBadges are able to record unrivalled footage of ongoing incidents.
